The manuscript should be written in Word and prepared in the following manner:

Font: *Times New Roman*; Text font size: *12 pt*; Margins: *Normal 2.54 cm*; Line spacing: *1.5*; Paper can have up to **40,000 characters with spaces**

The papers are published in Serbian, Russian and English with *Resume in English*.

TITLE OF THE PAPER

Abstract

Abstract, within 100–250 words range, contains the subject, aim, theoretical and methodological approach, results and conclusions of the paper.

Keywords: Below the abstract, five to ten key words

Tables, charts and figures should be inserted in the following manner:

- Above the table/chart/figure center the name of Table, Chart or Figure and ordinal number; Below the table/chart/figure, the source should be cited

References

References should be listed after the text of the paper with full bibliographic information.

Resume and key words in English.

CITING AND REFERENCING

Use in-text references - the author–date system of in-text parenthetical citation.

To cite the source use the following general rules:
